By proceeding and making payment, you are agreeing to these terms and conditions.

1. **DEFINITIONS**

The following words or expressions shall carry the meanings assigned thereto:

- 1.1. 'Contract' the following terms and conditions form the basis of the contract/agreement. This contract is the foundation to the services to be provided by Sunshine Coast Pop Up Weddings. No variations or modifications of this contract or the Tax Invoice will be accepted unless approved by Sunshine Coast Pop Up Weddings in writing.
- 1.2. 'You', 'Client', 'Couple" the person or persons engaging our services or hire items.
- 1.3. 'We', 'Us', 'Sunshine Coast Pop Up Weddings', 'SCPUW' Coast Wedding Co Pty Ltd T/A Sunshine Coast Pop Up Weddings ABN 39678871531
- 1.4. Our 'services' the services to be provided by us which include but are not limited to: event planning, event design, event hire, event management, event hosting, styling, booking agent on your behalf, provision of marketing support, project management, graphic design processes, market research, PR services, sponsorship and social media.
- 1.5. 'Our suppliers, 'collaborators', 'creators', 'vendors', 'SCPUW I Do Crew' our supply partners we work with to provide services/products.
- 1.6. 'Booking fee' the non-refundable booking fee require to secure your Sunshine Coast Pop Up Wedding package.
- 1.7. 'Package', 'Booking' the wedding package or amount as selected by the Client.

2. SERVICES

Sunshine Coast Pop Up Weddings is a wedding and event management company, planning, creating and coordinating wedding packages. Sunshine Coast Pop Up Weddings charges a non-refundable booking fee to secure its services and wedding packages on a specific date and time. You the Client has engaged Sunshine Coast Pop Up Weddings to be the booking agent to plan, secure, manage your payments and coordinate all elements including wedding vendors as listed in your invoice on your behalf. Services take place prior, on the day and after your wedding. As a guideline our general services are but not limited to the following:

- Email and phone conversations prior to booking
- Email Client Sunshine Coast Pop Up wedding invoice and electronic contract to sign
- One week after receiving your booking fee, secure all vendors as per your invoiced wedding package
- After receiving booking fee submit council permit or secure venue hire and wet weather venue (depending on invoiced wedding package)
- Arrange for allocated Celebrant and Photographer to email Client their vendor electronic contract to sign
- Email and phone conversations prior to booking to your wedding day (please see our office hours for more information)
- Email client exclusive access to our Reception and Industry Preferred Suppliers Package
- Email client Information Package exclusive to their location
- Pre-wedding consultation prior to your wedding day (in person or Skype depending on invoiced wedding package)



- Discuss, coordinate and execute Clients personalised selections in the Selection Forms
- Formulate and execute Clients personalised and comprehensive run sheet based on all communications with us and pre-wedding consultation including timeline, details and logistics
- Discuss any Client changes to the run sheet
- Discuss any vendor changes to the run sheet
- Distribute run sheet to Client and vendors
- On the day coordination of your invoiced wedding package for the allocated timeframe with Coordinator
- Greet vendors on your wedding day and oversee their set up
- Greet guests
- Assist and support Clients at the ceremony
- Cue officiant and music as needed
- Coordinate post-ceremony photos/liaise with photographer
- Ceremony styling set up and pack down
- Follow-up email post wedding to tie up any details with vendors and venue
- Follow-up post wedding coordination of digital gallery delivery with photographer

3. PAYMENT TERMS, BOOKING FEE & CONFIRMATION

- 3.1. The Client invoice will be emailed to you within 72 hours after submitting the booking form.
- 3.2. Upon acceptance and receipt of the invoice, payment of the non-refundable booking fee (amounts listed below) is immediately required to secure your wedding package, date and time. This booking fee is deducted from the final balance of your package.
- *All "Essentials and Elopement Packages \$990 non-refundable booking fee
- *All Eat, drink & be married Premium Packages \$1550 non-refundable booking fee *All Ceremony + Seated Reception Premium Packages - \$2000 non-refundable booking
- *Styling & Hire 30% non-refundable booking fee with a refundable SECURITY BOND
- 3.3. All payments are via direct deposit, to our nominated bank account, bank details are listed on your invoice. Proof of payment to be emailed to married@sunshinecoastpopupweddings.com.au Cheques are not accepted.
- 3.4. We are not able to hold bookings, our wedding packages are limited and are secured based on a first come first served basis.
- 3.5. Bookings are confirmed only when the non-refundable booking fee is received in cleared funds.
- 3.6. Within 72 hours of funds being cleared, you will receive an email to the email address provided with confirmation. You must notify Sunshine Coast Pop Up Weddings immediately if there have been any mistakes with your booking, or if you have not received the confirmation e-mail within 24 hours of payment.
- 3.7. Any council permits will not be purchased until a cleared booking fee has been received. We suggest you wait for our confirmation from council before making any further arrangements (this can take 3-4 weeks).



- 3.8. All premium packages are invoiced with a payment schedule. If client has breached the payment schedule Sunshine Coast Pop Up Weddings has the right to engage a debt collection agency and any costs incurred will be paid by the client.
- 3.9 The balance of the payment for the services contracted for must be paid in full 1 month prior to your wedding date.
- 3.10. Guest numbers must be confirmed 1 month prior to your booked wedding date. Sunshine Coast Pop Up Weddings will contact you for final guest numbers. Note, minimum guest numbers vary depending on your chosen package (see your invoice for the number of guests catered for your wedding). After this date additional guests can be added up to 7 days' prior. No deductions in numbers will be accepted 1 month from your wedding date.
- 3.11. Payment for additional services (e.g. extra guests, favours, hire items etc) is made when these are ordered and added to the contract and invoiced accordingly.
- 3.12. The booking fee is NON-REFUNDABLE under any circumstance unless outlined in 5.0.

4. SPECIFIC TERMS

- 4.1. The Contract starts when you have agreed to use our services and made payment of the booking fee.
- 4.2. If at any time a vendor we have engaged is not able to provide the product/service as originally quoted, we will endeavour to find a replacement of similar value/quality.
- 4.3. The Client booking will not proceed without a signed Sunshine Coast Pop Up Wedding Contract emailed by us.
- 4.4. The Client booking will not proceed without the Client signing the vendor Celebrant and Photographer Contract emailed to the Client by the vendor.
- 4.5. Based on selected wedding package, the Client booking will not proceed without the Client signing the venue Contract emailed to the Client by us.

5. CANCELLATION OR CHANGE OF DATE

- 5.1. The Client may cancel this Contract at any time by written notice to married@sunshinecoastpopupweddings.com.au but in doing so shall forfeit the non-refundable booking fee.
- 5.2. In the event of a client cancellation Sunshine Coast Pop Up Weddings reserves the right to retain the following cancellation fees to cover services prior, on the day and after the wedding including liquidated damages:
- \cdot 50% of the agreed package fee if cancelled between 90 days to six months prior to the wedding date
- \cdot 70% of the agreed package fee if cancelled between 31 days and 89 days prior to the wedding date
- · 100% of the agreed package fee if cancelled within 30 days of the wedding date.
- 5.3. On termination of the Contract the Client should immediately pay Sunshine Coast Pop Up Weddings the above cancellation charges less any amounts you have already paid, you will be invoiced accordingly.
- 5.4. In the event of cancellation please provide Sunshine Coast Pop Up Weddings with a nominated bank account for any refunds.
- 5.5. Change of date/Postponement subject to written notice to Sunshine Coast Pop Up Weddings. Depending on availability we may agree to a change of date. In this case, work completed to date will be payable upon receipt of an invoice, and you will be re-quoted on any additional hours/work required. Monies other than the booking fee may be used



as future credit on a new date at the discretion and availability of Sunshine Coast Pop Up Weddings and its suppliers. A new non-refundable booking fee will need to be paid for the new date.

- 5.6. Under the circumstance where Government guidance/authority is given to limit and/or suspend events and social gatherings we will adhere to these guidelines by law and reserve the right to not proceed with your event with any, if not all, booked items, hire or services. In these circumstances where we reserve the right to cancel your booking after recommendations to postpone/change of date were not agreed upon, we will not put our team, staff or families in jeopardy to their health and safety and no refunds of any payments made towards your booking will be issued.
- 5.7. Change of date/postponement due to Government guidance/authority has limited and/or suspended events and social gatherings depending on availability and in guidance with Government regulations we may agree to a change of date. The Client will have the option to postpone and given a cut-off date/time in which to make their decision by. The postponed date must be within 12 months of the original booking. If the postponed date falls outside the same financial year as the original booking an additional fee will be incurred. We will work with the Client towards a suitable postponement date. Failure to postpone your booking by the cut-off date will see a forfeit in your booking fee and any monies paid to date. Once a postponed date has been agreed upon, in these circumstances the booking fee and any monies paid to date will be transferred to the new date.
- 5.7.1 In the event the Client postpones due to their own preference or unique circumstances, where Government regulations/restrictions does not affect Sunshine Coast Pop Up Weddings and any third party or individuals associated with us from delivering/performing its contractual obligations to the Client, standard terms and conditions apply outlined in 5.5.
- 5.8. Client cancels due to Government guidance/authority has limited and/or suspended events and social gatherings if you choose to cancel your booking or no longer use Sunshine Coast Pop Up Weddings, standard cancellation terms outlined in 5.1, 5.2 and 5.3 will apply.
- 5.9. In the event of fines issued for not complying with Government regulations with the added recommendation from us, Sunshine Coast Pop Up Weddings and any third party or individuals associated with us will not be liable to pay any issued fines and these will be passed on to the Client who holds sole responsibility for their own event, attendees and individually sourced labour, contractors, vendors and suppliers.

6. FORCE MAJEURE

The due performance of this Contract and Client invoice is subject to alteration or cancellation by either party owing to any cause beyond their control. Neither party will be liable for failing to perform or underperforming its obligations under this agreement as long as the failure is triggered by something beyond its reasonable control. This clause does not excuse payment of monies due. In such an event Sunshine Coast Pop Up Weddings will not be liable to the Client, supplier and/or any further person or parties in respect of any loss and/or damage of whatsoever nature caused by or arising from any of the following circumstances:

6.1. Force Majeure – events beyond its reasonable control, unforeseeable circumstances, natural disasters such as but not limited to hurricanes, floods, fire, earthquakes and weather disturbances such as rain, wind, water levels, thunderstorm or



lightning. Other events may include war, terrorism or threats of terrorism, civil disorder, strikes or disruptions, disease or medical epidemics or outbreaks, and curtailment of transportation facilities preventing or delaying attendance.

- 6.2. The loss, damage, destruction or theft of any property on the wedding location/site.
- 6.3. Any act or circumstance, save for the gross negligence by the organiser, causing the loss, damage, destruction, theft and such other related events.
- 6.4. Loss or damage resulting from or related to the use of any equipment on the wedding location/site including but not limited to furniture, sound equipment and photographic equipment or technical failure thereof.

7. RIGHT OF WITHDRAWAL

Sunshine Coast Pop Up Weddings reserves the right of withdrawal if:

- 7.1. The Client breaches this Contract.
- 7.2. The Client is non-cooperative including missed appointments and late payments.
- 7.3. Factors out of our control such as changes in locations, facilities or available times arise along with discovery of new information, changes in agreed circumstances or similar which tend to circumvent its policies. Sunshine Coast Pop Up Weddings will provide a suitable alternative however if the couple should not wish to pursue the alternative we have the option to withdraw.
- 7.4. Should Sunshine Coast Pop Up Weddings initiate the withdrawal due to (7.1, 7.2 and 7.3) all fees will be refunded excluding the non-refundable booking fee.

8. LIMITS OF LIABILITY & INDEMNITY

- 8.1. Sunshine Coast Pop Up Weddings does not accept any liability for non-completion, under performance or for any delays arising as a result of war, terrorism or threats of terrorism, civil disorder, strikes, riots or lockouts, disease or medical epidemics or outbreaks, curtailment of transportation facilities preventing or delaying attendance, adverse weather conditions, loss, damage, under performance or cancellation due to hurricanes, floods, fire, earthquakes, rain, wind, water levels, thunderstorm or lightning or any other cause beyond its control.
- 8.2. The liability of Sunshine Coast Pop Up Weddings in respect of any breach of the Contract, including any applied terms shall not extend to any consequential loss whatsoever suffered by the client, supplier and/or any other or future person including guests or parties.
- 8.3. The Client hereby acknowledges that Sunshine Coast Pop Up Weddings may be limited by the terms and conditions, guidelines or rules of the engaged vendors/suppliers included in the package, the Celebrant performing the ceremony, the venue, the Council or the public and to hold Sunshine Coast Pop Up Weddings harmless for the impact such restrictions may have on the final product.
- 8.4. The Client, supplier and/or any other or future person including guests or parties hereby agrees to indemnify Sunshine Coast Pop Up Weddings and keep it indemnified against any claim, demand, action, suit or proceeding that may be made or brought against Sunshine Coast Pop Up Weddings, its employees and contractors for personal injury to or death of any person or loss of or damage to any property caused by, arising out of or as a consequence of this wedding package and its or associated services.

 8.5. The Client hereby acknowledges that Sunshine Coast Pop Up Weddings has not made any claim, statement or inference with regard to the suitability of the venue or land for the



wedding ceremony and/or reception package and its or associated services and the Client has satisfied itself in this regard.

- 8.6. LIMITATION OF LIABILITY. SUNSHINE COAST POP UP WEDDINGS ENTIRE LIABILITY FOR ANY CLAIM, LOSS, DAMAGE, OR INJURY ARISING UNDER OR RELATING TO THIS CONTRACT IS LIMITED TO THE FEES PAID BY CLIENT FOR THE SERVICES. IN NO EVENT SHALL SUNSHINE COAST POP UP WEDDINGS BE LIABLE FOR SPECIAL, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, EVEN IF CLIENT INFORMS SUNSHINE COAST POP UP WEDDINGS OF CIRCUMSTANCES THAT WOULD GIVE RISE TO SUCH DAMAGES.
- 8.7. Jurisdiction. The state and federal courts serving Queensland, Australia shall have exclusive jurisdiction over disputes arising from this Contract, and both parties here to consent to the jurisdiction of such courts.
- 8.8. Solicitor's Fees. The prevailing party in any litigation or dispute involving this Contract, or the Services performed there under, shall be entitled to recover reasonable solicitor's fees, costs, and expenses arising from such litigation or dispute from non-prevailing party.
 8.9. Suppliers. Sunshine Coast Pop Up Weddings does not accept any liability or claims for non-completion or for any delays incurred by suppliers. The Client is to deal directly with
- the vendor/supplier to seek compensation or further arrangements. If the non-completion or delay incurred by suppliers was due to circumstances out of our control then all parties including the supplier will do their best to provide the agreed wedding package on the wedding date or make arrangements at a later date for photo coverage and the official service by the Celebrant as a commitment ceremony will occur on the wedding date.
- 8.10. Waiver/Miscellaneous. This Contract represents the complete and entire agreement of the parties with respect to the subject matter herein, notwithstanding any oral or written representations to the contrary made before, during, or after its execution. Any amendments to this Contract shall only be effective if made in writing that is executed by both parties hereto.

9. INSURANCE

9.1. We have public liability insurance up to the sum of \$20 Million AUD

10. INCLEMENT WEATHER

- 10.1. Weather permitting, Sunshine Coast Pop Up Weddings honour the Contract as agreed. In the event of inclement weather being rain, high winds or lightning we will make the necessary changes:
- 10.2. If light rain is predicted we can proceed ahead in the outside location with umbrellas (Sunshine Coast Pop Up Weddings will have a maximum of 10 umbrellas available to use). Or at the Clients cost we can hire a marquee depending on location.
- 10.3. If heavy rain (inclement weather) is predicted we will implement the wet weather option and set up at the wet weather location.
- 10.4. With the exception of the 'Your Own Location' Package, Sunshine Coast Pop Up Weddings can hold two weddings on the same day at the same location our team assembles early that morning to commence setup and because of this model they can only setup once either the original ceremony site or the wet weather option. Sunshine Coast Pop Up Weddings has a duty of care to all couples getting married and their guests at every wedding they hold on your wedding date and location. If there is inclement weather being heavy rain, high winds or lightning during setup or forecasted for the day they will select the wet weather option as safety is the priority. Timelines do not permit SCPUW to re-setup styling in a different location between weddings. All weddings taking place on your wedding



day will remain at the same site. For example, if you have booked the morning wedding spot and there is forecasted inclement weather for that afternoon which may affect the afternoon wedding Sunshine Coast Pop Up Weddings will choose to set up at the wet weather option even if there is reasonable weather conditions that morning.

- 10.5. SCPUW will endeavour to provide all package inclusions that are reasonably possible. For peace of mind all our outside weddings come with a wet weather option unless stated otherwise.
- 10.6. SCPUW will notify clients of any changes 4-3 hours prior to their wedding start time.
- 10.7. If there is Premium Eat, Drink & be Married Package on your wedding date then we will need to decide the location 24hrs prior for catering purposes.
- 10.8. If all couples getting married on your wedding day and suppliers agree to the original outdoor location than we may proceed depending on the severity of the weather, safety is our priority. Sunshine Coast Pop Up Weddings does not accept any liability for non-completion of this Contract, claim, damage or injury if the Client chooses to proceed in the outdoor location.
- 10.9. In the event of inclement weather Sunshine Coast Pop Up Weddings endeavour to make the very best of the day and give you a high level of service you expect.

11. TIMELINES

Timelines are extremely important on a Sunshine Coast Pop Up Weddings event day, as we can host 2-3 wedding son the same day at the same location.

- 11.1. A general timeline for a 3pm wedding is, please note this is subject to changes.
- 2.45pm Groom and Guests Arrives at the Ceremony Location
- 2.55pm Bride Arrives
- 3.00pm Photographer Commences

Ceremony Begins (15-20min)

Signing of the Registry

3.30pm - Mingle with Guests

Group, Formal and Portrait Shots

- 3.45pm Bride & Groom photo shoot begins until the end of your allocated time spot
- 4.00pm *Cake, Food and Drinks are served

*Lawn Games (depending on package selected)

- 4.30pm "The essentials" package would conclude
- 5.00pm "Eat, Drink & Be Married Premium" Package would conclude

*SCPUW cookies (depending on package selected)

- *Indicates the premium package items
- 11.2. Guests are asked to arrive at the ceremony location NO earlier than 15min prior to your allocated time spot. This enables other weddings that are being held prior to yours to remain private.
- 11.3. Your wedding space is available to you for your allocated time spot depending on your package.
- 11.4. Sunshine Coast Pop Up Weddings and the Photographer is not responsible for reduced photographic coverage due to late arrival or start time from the Client, their guests and their third parties.
- 11.5. Unfortunately, if you are late this will reduce your allocated wedding package duration.



- 11.6. If you are late, we will give you an awesome ceremony and try to add as many inclusions as possible within the allocated time frame.
- 11.7. We ask that you and your guests please depart the wedding on time so as not to affect the next wedding, permits or venue hire periods.

12. PHOTOGRAPHY

- 12.1. Sunshine Coast Pop Up Weddings will allocate a photographer to your booking based on availability and brand standards.
- 12.2. The allocated photographer will email the Client their vendor Contract to sign. This vendor contract is the foundation to the services to be provided by the vendor. This vendor Contract must be signed for the booking to continue.
- 12.3. The Client will receive the number of digital images as outlined in their wedding package. Photographs are professionally edited and supplied digitally in high resolution. No RAW images or film will given to the client.
- 12.4. These will be supplied to you via an online digital album (gallery) that you can share with family and friends and you must download yourself. Please note, your images are delivered via online digital album you will need to download them as soon as possible and we suggest saving these to multiple devices as the online album will expire after 8 weeks.
- 12.5. Photographs are ready 5 weeks after your wedding date.
- 12.6. Protection of Deliverables/Retention of Files. The photographer shall take all reasonable steps to protect the images that are recorded at the Event until such time as the digital gallery is delivered/emailed to Client. Once the digital gallery has been delivered/emailed, Photographer or Sunshine Coast Pop Up Weddings shall have no further obligation to preserve the images of the Event, regardless of the form of media in which they are stored.
- 12.6. If Photographer is exposed to (i) unsafe conditions, or (ii) objectionable or illegal acts at the Event, the Photographer reserves the right to take reasonable action to remedy such a situation, including but not limited to leaving the Event. In such event, the Photographer and Sunshine Coast Pop Up Weddings shall not be obligated to refund any of the fees paid because of such action.
- 12.7. Model Release. Client hereby agrees that Photographer and Sunshine Coast Pop Up Weddings may reproduce, publish, exhibit, and otherwise use images from the Event for instructional or marketing purposes without payment of any additional fee, provided there is no specific identification of persons or events appearing in the images.
- 12.8. Force Majeure. If Photographer is unable to attend Event due to fire, flood, casualty, strike, civil disturbance, war, terrorism, or other acts of God beyond the parties' control, then Photographer shall return their monetary portion of the package if a change of date is not agreed upon. If Photographer is unable to attend the Event due to Photographer's sickness and there is reasonable time before this arising and the Event, the photographer will arrange a replacement photographer.
- 12.9. Liability. Sunshine Coast Pop Up Weddings does not accept any liability or claims for non-completion or for any delays incurred by suppliers. The Client and the Photographer has a binding contract between themselves, and the Client is to deal directly with the Photographer to seek compensation or further arrangements. If the non-completion or delay incurred by the Photographer was due to circumstances out of their control (e.g. a car accident or sudden sickness) then all parties will do their best to provide the agreed wedding package on the wedding date. If this arises on the wedding date and the Photographer cannot find a replacement Photographer, Sunshine Coast Pop Up Weddings



will do their best to take amateur photographs of the ceremony and the Photographer will make arrangements at a later date to complete the Bridal portraits, liability will not extend beyond this.

13. DISPLAY

- 13.1. The Client thereby permits Sunshine Coast Pop Up Weddings and it's suppliers to display any images covered by this Contract and to generally promote the business by means of advertising, publicity material, websites, exhibitions, competitions, magazine articles and/or other such media, providing that the images are used lawfully and without damage to the Client without further consideration or compensation.
- 13.2. It is specifically agreed that the images/material may be used on our Social Media channels and that the Clients maybe tagged or otherwise identified unless agreed otherwise in writing. This will only be done 2 days after the wedding date.

14. GUESTS & SEATING

- 14.1. Each Sunshine Coast Pop Up Wedding caters for the Bride and Groom plus a set number of guests depending on package selected.
- 14.2. You can add additional guests depending on your location limits (additional charges apply).
- 14.3. You are more than welcome to have a Bridal Party. Timelines are strict, so that you can maximise your wedding experience and photo shoot time, the complete bridal party will need to walk down the aisle within time frame of one bridal entrance song (the processional).
- 14.4. The bridal party is counted in your final number of guests.
- 14.5. Sunshine Coast Pop Up Weddings will have up to 26 chairs onsite due to council restrictions.
- 14.6. As a general rule if children can sit on the lap of an adult, they are not included in your guest count. For premium packages we will only provide wedding favours and catering based on your final number of paying guests.

15. CELEBRANT

- 15.1. Sunshine Coast Pop Up Weddings will allocate a Celebrant to your booking based on availability and brand standards.
- 15.2. The allocated Celebrant will email the Client their vendor Contract to sign. This vendor contract is the foundation to the services to be provided by the vendor. This vendor Contract must be signed for the booking to continue.
- 15.3. The Celebrant is to perform all legal requirements necessary to legally marry the Client.
- 15.4. If the Celebrant is exposed to (i) unsafe conditions, or (ii) objectionable or illegal acts at the Event, the Celebrant reserves the right to take reasonable action to remedy such a situation, including but not limited to leaving the Event. In such event, the Celebrant and Sunshine Coast Pop Up Weddings shall not be obligated to refund any of the fees paid because of such action.
- 15.3. Force Majeure. If the Celebrant is unable to attend Event due to fire, flood, casualty, strike, civil disturbance, war, terrorism, or other acts of God beyond the parties' control, then the Celebrant shall return their monetary portion of the package if a change of date can not be agreed upon. If the Celebrant is unable to attend the Event due to sickness and



there is reasonable time before this arising and the Event, the Celebrant will arrange a replacement Celebrant to conduct the service on the wedding date.

15.4. Liability. Sunshine Coast Pop Up Weddings does not accept any liability or claims for non-completion or for any delays incurred by vendors/suppliers. The Client and the Celebrant have a binding contract between themselves, and the Client is to deal directly with the Celebrant to seek compensation or seek further arrangements. If the non-completion or delay incurred by suppliers was due to circumstances out of their control (e.g. a car accident or sudden sickness) then all parties including the supplier will do their best to provide the agreed wedding package on the wedding date. If this arises on your wedding date a commitment ceremony will be performed by Sunshine Coast Pop Up Weddings and the Celebrant will make arrangements at a later date to complete the official legal service, liability will not extend beyond this.
